1. **Do not send** hard copies of application format or certificates by post.
2. **Application format** deviating from the format will not be considered and no communication in the regard will be entertained.
3. **No call letters will be issued.** Applicants are expected to **be present at the interview venue on the said date and time.** Bring hard copies of duly filled application in prescribed format along with one set of self-attested photocopies of their certificates and original certificates with two copies of recent passport size photo for verification
4. **Late arrival (After 10:00 AM)** of applicants for the interview will be considered as absent.

1. **The candidates should compulsorily bring One copy of duly filled application form in the prescribed proforma only (Given in Annexure-I), two passport size photographs and one set of self-attested photocopies of their certificates/ mark-sheets/ experience proof etc. Applicants must bring with them original documents at the time of interview for verification.**
